#### MINUTES OF A REGULAR MEETING OF THE BOARD OF EDUCATION OF THE METROPOLITAN SCHOOL DISTRICT OF NORTH POSEY COUNTY, INDIANA

Held October 11, 1982

The regular meeting of the Board of Education of the Metropolitan School District of North Posey County, Indiana was held in the office of the superindent of schools on the 11th day of October, 1982, at the hour of 7:30 o'clock P.M., with Board Members Nash, Martin, Buecher, and Williams present. Also attending were Superintendent Brenton and Administrative Assistant Rapp.

The meeting was called to order by President Nash, who presided. Minutes of the previous meeting of September 22, 1982 were read to the Board and approved as read.

#### Claims

General Fund Claims No. 217-257 and 261 in the amount of \$11,575.81,Transportation Fund Claims No. 65-74 in the amount of \$9540.02, Cumulative Building Fund Claims No. 258-260 in the amount of \$697.78, Public Law 94-142 Claims No.6-8 in the amount of \$338.70 and Chapter I claims No. 2 and 3 in the amount of \$92.85 were presented to the Board for consideration, and upon motion duly made by Williams and seconded by Buecher and unanimously carried were approved by the Board and ordered paid.

#### Additional Appropriation

The president called the attention of the Board to the fact that it was the time advertised for hearing on the proposed additional appropriation in the amount of \$15,000.00 into Account No. 25350 - Cumulative Building Fund. There were no remonstrances against the proposed additional appropriation and following a discussion, upon motion duly made, seconded and unanimously carried, it was determined by the Board that such a need did exist, and an additional appropriation in the amount of \$15,000.00 in Account No. 25350 - Cumulative Building Fund was made by the Board. The Superintendent was instructed to forward the necessary copies of the resolution and of the proofs of publication to the Auditor of Posey County for additional hearing before the State Board of Tax Commissioners.

Beginning with the 1983-84 school year all cash transfer students (students with legal residence outside the M.S.D. of North Posey County) desiring to attend school in the M.S.D. of North Posey County will be required to make a one semester advance payment to the M.S.D. of North Posey County prior to enrollment of the student by the building Principal at the beginning of each semester.
