The meeting was called to order by President Nash, who presided. Minutes of the previous meeting of August 27, 1987, were read to the Board and approved as read.

Claims

General Fund Claims No. 114-186 in the amount of \$12,078.91, Transportation Fund Claims No. 30-42 in the amount of \$3582.99, Public Law 94-142 Claim No. 3 in the amount of \$492.00 and Construction Fund - South Terrace Proj. # 13033 claims No. 130 - 131 in the amount of \$5,298.50 were presented to the Board for consideration and upon motion duly made by Martin, seconded by Buecher and unanimously carried were approved by the Board and ordered paid.

The Board of Education of the Metropolitan School District of North Posey County, Indiana, was held in the Office of the Superintendent of Schools on the 27th day of September, 1987, at the hour of 7:00 o'clock P.M., with Board Members Nash, Martin, Williams and Krietenstein present. Also attending were Superintendent Brenton and Administrative Assistant Rapp.

At 7:00 P.M. it was the decision of the Board to go in Executive Session to discuss personnel and other administrative matters. The Board secured from Executive Session at 7:30 P.M.

The meeting was called to order by President Nash, who presided. Minutes of the previous meeting of September 14, 1987 were read to the Board and approved as read.

Claims

General Fund Claims No. 188-248 in the amount of \$13,758.30, Transportation Fund Claims No. 44-47 in the amount of \$325.25, Public Law 94-142 Claims No. 4-8 in the amount of \$867.85 and 94-142 Part B Claims No. 1-5 in the amount of \$382.58, were presented to the Board for consideration, and upon motion duly made by Martin, seconded by Krietenstein and unanimously carried were approved by the Board and ordered paid.

New Addition - North Posey High School

Mr. Brenton reported to the Board that classes were now being held in the eight new classrooms added to the front of North Posey High School. The Superintendent explained to the Board that Harrell Electric was now working a second shift so they would not disturb classes during the day. He further reported that Arc Construction expected to have the new gymnasium completed by January 1, 1988.

Staff Development Program

Mr. Brenton informed the Board that a new staff development program, Teachers Teaching Teachers, was presented to the North Posey staff on September 23, 1987 by a cadre of teachers from Mt. Vernon. He also explained to the Board that he and Mr.Rapp would be meeting with representatives of NEA North Posey on Tuesday, September 29, 1987 to discuss the staff development program which had been presented by the Mt. Vernon teachers.

Request of North Posey H.S. Future Farmers of America

Mr.Brenton read a letter received from Matt Williams, Vice President of the North Posey FFA Chapter, requesting permission for representatives of the Chapter, along with Mr. Neufelder, to attend the FFA National Convention to be held in Kansas City on November 11 - 14, 1987. Upon the recommendation of Mr. Brenton, on a motion duly made by Martin, seconded by Krietenstein and unanimously carried, the request was approved. A copy of the letter of request shall be made a part of the minutes by incorporation.

Student Enrollment (A.D.M.)

Superintendent Brenton reported the total student enrollment for the 1987-88 school year on the A.D.M. (Average Daily Membership) count day, September 18, 1987, was 1617. He further explained that the district had 23 more students than the previous school year. A hand out sheet listing the A.D.M. over the past twelve years shall be made a part of the minutes by incorporation.

N.E.A. North Posey

Mr. Brenton read a letter to the Board he had received from Lisa Koester, President of N.E.A. North Posey, stating that N.E.A. North Posey, in accord with PL. 217, stood ready to bargain a contract for the 1988-89 school year. A copy of the letter shall be made a part of the minutes by incorporation.

Auction - Surplus

The Board declared school furniture and equipment from all schools which would be brought to the old Poseyville Gym as surplus and set Saturday, October 17, 1987 as the date for a public auction to sell the surplus items. The sale is to begin at 10:00 A.M.

Sewage Plant

Mr. Brenton read a letter received from Gene Wilderman of Kramer Group outlining cost proposals for replacing the present sewage line from the Jr-Sr High School out to the disposal plant. Following a discussion, it was the decision of the Board to have Mr. Brenton investigate other alternatives for the replacement of the line rather than consider the proposals which had been submitted by Kramer Group.

Request of John Wood

The Board approved John Wood's request to attend the I.S.S.P. Fall Conference to be held in Indianapolis on October 21 -22, 1987.

I.S.B.A. Fall Meeting

Mr. Brenton informed the Board that the I.S.B.A. Fall meeting would be held at the Jasper Country Club on October 26, 1987.

Following no further discussion of school matters, upon motion duly made and seconded, the meeting adjourned at the hour of 9:00 P.M.
