HELD August 10, 1992

The regular meeting of the Board of Education of the M.S.D. of North Posey County, Indiana, was held in the Office of the Superintendent of Schools on the 10th day of August, 1992, at the hour of 5:30 P.M., with Board Members Baehl, Saxe, Buecher and Lewis present. Also attending were Superintendent Brenton and Administrative Assistant Rapp.

At 5:30 P.M. it was the decision of the Board to go into an Executive Session to discuss personnel and negotiations on the 1992-93 Master Contract with the classroom teachers association. The Board secured from Executive Session at 6:15 P.M.

The meeting was called to order by President Baehl, who presided. Minutes of the previous meetings of July 13 and July 20, 1992 were read to the Board and approved as read.

Claims

A copy of the Claim Docket was presented to the Board for their consideration. Upon a motion made by Lewis, seconded by Beucher and unanimously carried, the Claim Docket was approved by the Board. A copy of the approved claim docket shall be made a part of the minutes by incorporation.

Public Law 240-1991 - Capital Projects Resolution

On a motion made by Saxe, seconded by Lewis and unanimously carried, the Board approved a Resolution which will allow a portion of the M.S.D. of North Posey County's Capital Projects Fund tax levy to be used to pay actual increases in health care costs for corporation employees that occur after July 1, 1992 for coverage in effect on or before January, 1992. A copy of the Resolution shall be made a part of the minutes by incorporation.

Update on Lawsuit on Funding Equalization

Superintendent Brenton reported to the Board that he and twenty four other school superintendents recently met in Indianapolis with Governor Bayh to discuss the school equalization funding lawsuit which the districts had filed against the State of Indiana. He explained to the Board that Governor Bayh promised he would work with the state legislature during the next session of the General Assembly to equalize the school funding formula for Indiana School Districts. The school superintendents agreed to drop the law-suit for the present time in order to give the Governor the opportunity to correct inequitities in the school funding formula during the next legislative session.

Electronic Fund Transfer Resolution

On a motion duly made by Buecher, seconded by Lewis and unanimously carried, the Board approved a Resolution authorizing the school district treasurer to transact the school district's business with Citizens Bank of Posey County via electronic funds transfer (IC 4-8.1-2-7). A copy of the Resolution shall be made a part of the minutes by incorporation.

Board Minutes Aug. 10, 1992

Kindergarten Teacher - South Terrace

Upon the recommendation of Mr. Brenton, on a motion made by Saxe, seconded by Buecher and unanimously carried, the Board approved the move of Linda Andry from the 4th grade to kindergarten at South Terrace to fulfill the teaching position formerly held by Jane A. Gaunt. The Board also unanimously approved the re-employment of Staci Voegel to teach 4th grade at South Terrace for the 1992-93 school year.

Soccer Facility - North Elementary

Following a discussion the Board approved the use of a portion of the playground area at North Elementary for youth soccer during the 1992-93 school year.

Concession Stand and Press Box

Mr Brenton explained to the Board that he was very pleased with the volunteer workers who have given of their time on weekends in building the new concession stand behind the football bleachers and the new press box behind the backstop of the baseball diamond at North Posey High School. He explained that he would provide a list of all the volunteer workers and contributions made by various people once the projects were completed.
