Executive Session

The Board convened the Executive Session at 5:30 p.m. for the purpose of IC 5-14- 1.5-6.1 (9) to discuss a job performance evaluation of individual employees. The Board adjourned Executive Session at 6:20 p.m.

Regular Meeting

The Board of Education convened for the regular meeting at 6:33 p.m. with President, Greg Schmitt, calling the meeting to order with the initiation of the Pledge of Allegiance.

Patron Concerns

Emily Hampton, Kate Brown, Brittney Fisher, and Megan Helfert addressed the Board requesting a third section be considered for first grade at North Elementary for 2023-2024. The patrons discussed the unique situation with unprecedented student behavior problems in kindergarten, and they felt students were adversely affected by the shutdown during the pandemic. Brittney Fisher also expressed concern for increased negative behaviors occurring in the special education room.
