### Regular Meeting

The Board of Education convened for the regular meeting at 6:33 p.m. with President, Greg Schmitt, calling the meeting to order with the initiation of the Pledge of Allegiance.

# Recognition of Carrie Schmitt and the 2023 Girls' Softball Champions

### **New Business**

Dr. Galvin informed the Board that according to Indiana state law, effective January 1, 2024, the School Lunch and Textbook Accounts held at North Posey High School under the direction of Carolyn Price, Sean Fisher, and Amy Duvall are to be moved to the MSD of North Posey County Central Office under the direction of Dr. Michael Galvin, Amanda Lynn, and Bobbie Rankin. To ensure a cleaner transfer, we shall make the switch effective July 1, 2023. The textbook portion of \$83,660.69 will be incorporated into the 0900 Accounts. The school lunch portion of \$292,991.31 will be incorporated into the 0800 Accounts. The food-in-trust account of \$15,789.47 will be placed in the 8400 account. Mrs. Bowers made a motion to approve this move and Mr. Kahle seconded the motion. The motion was approved with a 5 to 0 vote.
