Executive Session

The Board convened the Executive Session at 5:30 p.m. for the purpose of IC 5-14- 1.5-6.1 (3 & 9) for discussion of the assessment, design, and implementation of school safety and security measures and to discuss a job performance evaluation of individual employees. The Board adjourned Executive Session at 6:28 p.m.

Regular Meeting

The Board of Education convened for the regular meeting at 6:34 p.m. with President, Vince Oakley, calling the meeting to order with the initiation of the Pledge of Allegiance.

Reading of the Vision, Mission, Core Beliefs, & High Priorities

Mr. Slagle read the Vision, Mission, Core Beliefs, and High Priorities.

Patron Concerns

There were no patrons present to address the Board.

Minutes, Claim Docket and Consent Items

Vince Oakley asked the Board for a motion to approve the consent items as listed:

Mrs. Bowers made a motion to approve the consent items as presented and Mr. Kahle seconded the motion. The motion passed 5 to 0.

New Business

Mr. Slagle recommended the Board revise the High Priorities to state "Investing in administrators and staff" instead of "Investing in teachers and administrators" to be inclusive to all employees. Mr. Kahle made a motion to approve the recommendation and Mrs. Neidig seconded the motion. The motion was approved with a 5 to 0 vote.

Mr. Slagle presented for consideration the Resolution Authorizing HEA 1003 Flexibility Waiver to use instructional minutes rather than instructional days. Mr. Schmitt made a motion to approve the request and Mrs. Bowers seconded the motion. The motion was approved with a 5 to 0 vote.

Mr. Slagle presented to the Board the request from Stacy Newman-Smith, Food Service Director, to purchase six (6) new computers for the cafeteria registers at a cost of \$5,149.49. Mr. Schmitt made a motion to approve the request and Mr. Kahle seconded the motion. The motion was approved with a 5 to 0 vote.

Dr. Walden, present virtually, presented to the Board for first read the Students section of the Neola Policy. No action is required of the Board currently. The Students section shall be presented to the Board for second read and approval in the May meeting.

Mr. Slagle requested the Board approve the corporation to advertise the Request for Proposal (RFP) for Banking Services for Extra Curricular Accounts. As per the RFP, proposals will be accepted through May 2, 2024, with the Board selecting a provider during the May 13, 2024,

meeting. Mr. Kahle made a motion to approve request and Mrs. Neidig seconded the motion. The motion passed 5 to 0.

Mr. Slagle requested the Board approve the corporation to advertise the Request for Proposal (RFP) for a Food Service Management Company pending approval of the RFP by the Indiana Department of Education School and Community Nutrition Program. As per the RFP, proposals will be accepted through May 15, 2024, with the Board selecting a provider during the June 10, 2024, meeting. Mrs. Neidig made a motion to approve request and Mr. Schmitt seconded the motion. The motion passed 5 to 0.

Mr. Slagle requested the Board approve the contract with Lamar to advertise on the billboard located on Winterheimer road from May 20, 2024, through May 18, 2025. The cost is \$2,125.00 from the ESSR III fund. Mr. Kahle made a motion to approve the contract and Mrs. Bowers seconded the motion. The motion passed 5 to 0.

Mr. Slagle presented to the Board for consideration the recommendation from Sean Fisher to add new courses to the High School; Civil Construction Fundamentals, Advanced Civil Construction, Principles of Education, Child and Adolescent Development, Teaching and Learning, and Digital Media. Mr. Schmitt made a motion to approve the new courses and Mrs. Neidig seconded the motion. The motion passed 5 to 0.

Dr. Walden, present virtually, communicated to the Board that the spring 2024 textbook adoption for miscellaneous curriculum was in progress. Adoption materials were available to the Board in their packet. The materials shall also be available to the public for review at each building office as well as the district office. No action is required of the Board currently. The recommended curriculum will be brought to the Board for approval in the May meeting.
