Minutes of a Regular Meeting of the Board of Education of the Metropolitan School District of North Posey County, Indiana,

Held July 11, 1966

The regular meeting of the Board of Education of the Metropolitan School District of North Posey County, Indiana, was held on the 11th day of July, 1966, at the hour of 7:30 o'clock, P.M., in the office of the Superintendent of Schools. Attending were board members Tenison, Meredith, Wade, Fletchall, and Hall. Also attending were Superintendent Hollen and Attorney Schuler.

The meeting was called to order by President Tenison, who presided. Minutes of the previous meeting of June 30 were read to the board and upon motion duly made by Wade, seconded by Hall, and unanimously carried, were approved.

Regular claims No. 3 through No. 27 inclusive, Title I claims No. 61 and 62, and Title II claims No. 8 through No. 12 were presented to the board for consideration, and upon motion by Fletchall, seconded by Hall and unanimously carried, were approved by the board, signed and ordered paid.

The Superintendent reported receipt of letter of resignate ion from Mr. and Mrs. Jan Blackburn, who had recently been hired as Guidance Counselor and Elementary school teacher. This resignation was accepted by the board. The Superintendent recommended to the board the hiring of Miss Sharon Mountcastle as a First grade teacher at South Terrace. Following a short discussion, the board directed that Miss Mountcastle be hired and executed a contract in her behalf.

The Superintendent reported to the Board that the water system at South Terrace school had broken down and was in the process of being repaired by Don Little & Company, the original installer of the well.

A discussion was held by the board on several matters relating to school business, and the Superintendent reported to the board that it was likely that the new Vo Ag teacher would want to attend a workshop for beginning Vo Ag teachers to be held at Purdue University on July 25 through July 29. Permission was granted by the board for the teacher to attend this meeting.

Thereafter, on motion duly made, seconded and unanimously carried, the meeting adjourned at the hour of nine o'clock, P.M.
