The regular meeting of the Board of Education of the Metropolitan School District of North Posey County, Indiana, was held in the office of the Superintendent of schools on the 11th day of August, 1980, at the hour of 7:30 o'clock p.m., with Board Members Eisterhold, Newman, Hall, Nash, and Martin present. Also attending were Superintendent Brenton, Administrative Assistant Rapp, and School Attorney Johnson.

The meeting was called to order by President Eisterhold who presided. Minutes of the previous meeting of July 28, 1980, were read to the Board and approved as read

Claims

Claims No. 71-120 in the amount of \$6,828.80, Public Law 94-142 Claim No. 1 in the amount of \$83.82, Cumulative Building Fund Claim No. 119 in the amount of \$3,500.00, and Transportation Fund Claims No. 11-19 in the amount of \$8,219.10 were presented to the Board for consideration, and upon motion duly made by Hall, seconded by Nash, and unanimously carried were approved by the Board and ordered paid.

All-Weather Track

Mr. Brenton reported that the all-weather track would be striped on Wednesday of this week, weather permitting. He further reported that the installation of the new steel bleachers on the west side of the football field had been completed.

Relocatable Classroom - South Terrace

The Superintendent reported that the State General Commission had approved the school district's request for the use of a relocatable classroom at the South Terrace Elementary. He further reported that the installation of the new classroom was in progress at South Terrace and would be completed in time for the opening of school.

Blue Cross-Blue Shield Health Insurance

Mr. Brenton reported the new group health insurance rates received from Blue Cross-Blue Shield effective November 1, 1980 thru October 31, 1981 as follows:

Transportation

Nutrition Agreement

This agreement is designed to reimburse the school district for free or reduced priced meals or milk given to students. The agreement was signed by Board President Eisterhold.

Substitute Teacher Pay

The Superintendent informed the Board that Evelyn Brown had requested a one year leave-of-absence from her teaching position (1980-81 school year) due to the illness of her husband. Mr. Brenton explained to the Board that Mrs. Brown had taught one year in the corporation and had done a very creditable job in her teaching assignments. Following a discussion and after giving due consideration, it was the decision of the Board not to grant Mrs. Brown a one year leave-of-absence.

Travel Mileage Reimbursement

Following a discussion the Board increased the mileage pay to 22° per mile for traveling personnel for the 1980-81 school year.

The Superintendent also reported that Midwest Construction would complete all work on the all weather track by next week.

Transportation

He further reported to the Board on the total gallons of gasoline delivered at South Terrace Elementary, North Posey High School and the bus garage between August 1, 1979 and July 31, 1980.
