# MINUTES OF A REGULAR MEETING OF THE BOARD OF EDUCATION OF THE METROPOLITAN SCHOOL DISTRICT OF NORTH POSEY COUNTY, INDIANA

Held August 10, 1981

The regular meeting of the Board of Education of the Metropolitan School District of North Posey County, Indiana was held in the office of the Superintendent of Schools on the 10th day of August, 1981, at the hour of 7:30 o'clock P.M. with Board members Eisterhold, Newman, Hall and Martin present. Also attending were Superintendent Brenton and School Attorney Johnson.

The meeting was called to order by President Eisterhold who presided. Minutes of the previous meeting of July 27, 1981 were read to the Board and approved as read.

#### Claims

General Fund Claims No. 55 - 93 in the amount of \$100,478.86, Transportation Claims No. 19 - 26 in the amount of \$7030.02, Cumulative Building Fund Claims No. 94 - 96 in the amount of \$1811.78 and Federal Funds 89-313 Claim No. 10 in the amount of \$79.04 were presented to the Board for consideration and upon motion duly made by Newman, seconded by Hall and unanimously carried, were approved by the Board and ordered paid.

#### Odle Report on Roof

Mr. Odle gave an update on the High School roof and his report was complete in regard to each phase of construction. He stated the final inspection will be made the middle of October and until then a 10% retainage fee will be withheld.

#### Budget Advertised

Mr. Brenton reminded the Board that the school budget for 1982 had been advertised as per law and subject to approval Thursday, August 27, 1981.

# Board of Education Meetings

The Board will meet August 21, 1981 for a hearing of the proposed budget of 1982 and August 27, 1981 to adopt the budget. Also, the Board will have a regular meeting on August 27th, 1981 instead of Monday, August 24th, 1981.

#### Scott Boiler Proposal

Mr. Brenton explained to the Board four different plans of heating the old gym for the coming school year of 1981 - 82. Scott Boiler System proposed a complete change to gas, two gas furnaces, two hot water exchange furnaces, or fix the present boiler. After considerable discussion the Board decided to fix the present boiler at a cost of \$400 to \$500 instead of installing new furnaces at an estimated cost of \$6,000 to \$7,000.00.

### Choral Instructor

Upon recommendation of the Superintendent the Board approved the employment of Lisa Eissler as a general music teacher in the Junior High School and choral director at the Senior High School.

# Transportation

Mr. Brenton reported the four (4) new buses have arrived in time for the opening of school.

He shared with the Board copies of Mr. Rapp's year end expenditures, one of which will be made a permanent part of these minutes.

### Executive Session

At 8:45 P.M. it was the decision of the Board to go into Executive Session for the purpose of discussing personnel matters.

The Board secured from Executive Session at 9:15 P.M.
