Transportation

Mr. Rapp reported to the Board on the cost of gasoline for the bus fleet for the month of November, 1981. Mr. Rapp requested permission to advertise for bids on three school buses to be opened at the Board meeting on January 18, 1982 Following a discussion of the specifications prepared for the vendors the Board approved Mr. Rapp's request to advertise for bus bids.

Approval to Transfer Appropriations and Pay Outstanding Bills
