The regular meeting of the Board of Education of the Metropolitan School District of North Posey County, Indiana, was held in the office of the Superintendent of Schools on the 15th day of August, 1984, at the hour of 7:00 o'clock P.M., with Board Members Nash, Martin, Hall, Buecher and Williams present. Also attending were Superintendent Brenton and Administrative Assistant Rapp.

At 7:00 P.M. it was the decision of the Board to go into Executive Session to discuss negotiations and personnel. The Board secured from Executive Session at 8:00 P.M.

The meeting was called to order by President Nash, who presided. Minutes of the previous meeting of July 30, 1984 were read to the Board and approved as read.

Claims

General Fund Claims No. 63 - 98 in the amount of \$15,286.96, Cumulative Building Fund Claims No. 99 - 101 in the amount of \$26,415.65, Transportation Fund Claims No. 23 - 28 in the amount of \$6,456.59 and Public Law 94-142 Claims No. 1 and 2 in the amount of \$365.00 were presented to the Board for consideration, and upon motion duly made by Martin, seconded by Buecher and unanimously carried were approved by the Board and ordered paid.

Recommendation of Industrial Arts Teacher

Upon recommendation of the Superintendent, on a motion duly made by Hall seconded by Williams and unanimously carried, the Board approved the employment of Randy A. Abel as an Industrial Arts teacher at the High School for the 1984-85 school year.

Transportation

Mr. Rapp reported that Nix Bus Sales had delivered the two new buses (Chev/Blue Bird) to the District and that they would be on routes the first day of school. He further reported that he had held his annual pre-school organizational meeting with the bus drivers on August 14 and that the Indiana State Police Bus Safety Inspection would be on September 26th at the District bus garage.

Update on Maintenance

The Superintendent reported that the following projects had been completed:

South Terrace Replacement of the tile in the hallways and foyer and the new storage building completed.

North Posey Jr & Sr. H.S. The sealing of the tennis courts and all weather track; the sealing of the cracks in the parking lot; and the installation of carpeting in the band room

North Elem.

Mr. Rapp reported to the Board that a tentative agreement on a Master Contract had been reached for a two year package (1983-84 and 1984-85) at 2:58 A.M. on August 15, 1984. He informed the Board he expected to present it to them for ratification at their next regularly scheduled meeting on August 30, provided the two year agreement was approved by N.E.A. North Posey prior to this date.

Held August 22, 1984

The Board of Education of the Metropolitan School District of North Posey County Indiana met in special session on the 22nd day of August, 1984, at the hour of 7:00 P.M. in the office of the Superintendent of Schools with Board members Nash, Martin, Hall, Williams and Buecher present. The meeting was called to order by President Nash, who presided and stated that the purpose of the meeting was for public review of the budget as advertised for the calendar year 1985 and to answer questions the public may have concerning the budget.
