Held December 14, 1987

The regular meeting of the Board of Education of the M.S.D. of North Posey County, Indiana was held in the Office of the Superintendent of Schools on the 14th day of December, 1987, at the hour of 7:00 o'clock P.M., with Board Members Nash, Williams, Buecher and Krietenstein present.
