Executive Session

The Board convened the Executive Session at 5:30 p.m. for the purpose of IC 5-14-1.5-6.1 (9) to discuss job performance and evaluation of individual employees. The Board adjourned Executive Session at 6:25 p.m.

Regular Meeting

The Board of Education reconvened for the regular meeting at 6:33 p.m. with Board President, Larry Lewis, calling the meeting to order with the initiation of the Pledge of Allegiance. Minutes of the previous meeting, held on September 17, 2007, were submitted to the Board. Upon a motion made by Mr. Bender, and seconded by Mr. Baehl, the minutes were approved with a 5 to 0 vote.

Claim Docket

A copy of the current claim docket was presented to the Board for consideration. Upon a motion made by Mr. Bender, seconded by Mr. Seibert, the claim docket was approved on a 5 to 0 vote. A copy of the claim docket shall be made a part of the official minutes by incorporation.

New Business

Mr. Lewis announced the opening of the Public hearing at 6:40 p.m. regarding the request for an additional appropriation of \$350,000 for the Capital Projects Fund Three patrons were present to ask questions on another matter, but there were no patrons present to remonstrate against the request for an additional appropriation. Mr. Lewis closed the hearing at 7:03 p.m.

October 8, 2007

Mr. Wood presented a letter requesting the use of the high school facility by the North Posey Youth Basketball program. The high school athletic director will secure dates and times. Mr. Baehl made a motion to allow the facility usage, and Mrs. Mauck seconded the motion. The motion carried 5 to 0.

Mr. Wood asked the Board to adopt a resolution to approve an additional appropriation in the amount of \$350,000 for the Capital Projects Fund. The money will be transferred from the Rainy Day Fund. Mr. Bender made a motion to approve the resolution, and Mr. Baehl seconded the motion.

Personnel

Mr. Wood presented a recommendation from Mr. Camp on eliminating the part time Physical Therapist position. Juli Purcell who is a Physical Therapist Assistant, PTA is currently filling the position. The position will be eliminated as of November 5, 2007. At that time, we will utilize the services of a fully licensed physical therapist. Mrs. Mauck made a motion to approve the request and Mr. Seibert seconded the motion. The motion carried 5 to 0.

Mr. Wood asked the Board to approve the addition of an instructional aide to support the North Elementary special education department. Linda Culver is to fill this part time position. Mrs. Mauck made a motion to approve the request, and Mr. Bender seconded the motion. The motion carried 5 to 0.

Mr. Wood asked the Board to approve Gary Gentil's request to approve Chris Wehmer and J.R. Seymour as volunteer varsity basketball coaches. Mr. Ferguson and Mr. Strieter concur with this request. Mr. Baehl made a motion to approve the request, and Mr. Bender seconded the motion. In error, two names were left off the request. Mr. Bender amended the motion to include Robert Gentil and Jeremy Schipp as additional volunteer varsity basketball coaches for the 2007-08 season. Mr. Seibert seconded the amended motion. The amended motion carried 5 to 0.
