# Minutes - Regular Meeting of the <br> Board of Education of the Metropolitan School District of North Posey County, Indiana 

November 14, 2011
A meeting of the Board of Education of the MSD of North Posey County, Poseyville, Indiana, was held in the Board Office on November 14, 2011. The following Board members were present:

## Executive Session

The Board convened the Executive Session at 5:30 p.m. for the purpose of IC 5-14-1.5-6.1 (9) to discuss job performance and evaluation of individual employees. The Board adjourned Executive Session at 6:37 p.m.

## Regular Meeting

The Board of Education convened for the regular meeting at 6:40 p.m. with Board President, Joe Neidig, calling the meeting to order with the initiation of the Pledge of Allegiance. Minutes of the previous meetings was presented to the Board for October 12, 2011 and November 1, 2011. Upon a motion made by Mr. Bender and seconded by Mrs. O’Risky, the October 12, 2011 minutes were approved with a 5 to 0 vote. Upon a motion made by Mr. Gentil and seconded by Mr. Bender, the November 1, 2011 minutes were approved with a 5 to 0 vote.

## Claim Docket

A copy of the claim docket for the period of October 13, 2011 to November 14, 2011 was presented to the Board for consideration. Upon a motion made by Mr. Bender, seconded by Mr. Lewis, the claim docket was approved with a 5 to 0 vote. A copy of the approved claim docket shall be made a part of the official minutes by incorporation.

## New Business

Dr. Camp presented to the Board handouts of several current policy and procedures to review and discuss possible modifications. No action needed at this time.

Dr. Camp asked the Board to approve the proposal from Harshaw Trane to replace a defective DX9100 JCI Controller at South Terrace Elementary School for $\$ 4,397.00$. The controller would be purchased through the Capital Projects Fund. A motion was made to approve the request by Mr. Lewis seconded by Mr. Bender and carried with a 5 to 0 vote.
Dr. Camp asked the Board to approve the annual Komputrol Disaster Recovery Agreement for $\$ 450.00$. The agreement protects the district from loss of data maintained by the Komputrol
software programs used by the Central Office Staff; budgetary, payroll, and personnel. A motion was made to approve the request by Mrs. O'Risky seconded by Mr. Gentil and carried with a 5 to 0 vote.

Dr. Camp presented Shannon Schickel's request to take 33 high school students on an overnight trip to the Student Council State Convention in Indianapolis on November 5-6, 2011. The agenda for the students is in the packet. The students and student council will be covering the cost for the trip. A motion was made to approve the request by Mr. Bender seconded by Mr. Lewis and carried with a 5 to 0 vote.

Dr. Camp presented the facility use requests from Cub Scouts PAC 390 and Girl Scouts of Southwest Indiana (Troop 346) to use the South Terrace gym for their meetings as listed. A motion was made to approve the requests by Mr. Bender seconded by Mrs. O'Risky and carried with a 5 to 0 vote.

Dr. Camp presented a request from Julie Butler to conduct a Dance Team clinic January $21^{\text {st }}$ and a Cheer Team clinic on February $18^{\text {th }}$ at the high school from 8:00 a.m. to 12:30 p.m. These students will perform at the JV and Varsity games on their respected evenings. A motion was made to approve the requests by Mr. Lewis seconded by Mr. Gentil and carried with a 5 to 0 vote.

A motion was made by Mr. Bender to approve the request and Mrs. O'Risky seconded the motion. The motion carried with a 5 to 0 vote.

Dr. Camp presented a request from Nancy Dougan to hire Kathy Veeck as the Head Cook at South Terrace cafeteria. A motion was made by Mrs. O'Risky to approve the request and Mr. Gentil seconded the motion. The motion carried with a 5 to 0 vote.

Dr. Camp presented a request from Mr. Kavanaugh to have Kelvin Kerchief as a volunteer assistant coach for the $7^{\text {th }}$ grade boys' basketball team for the 2011-12 season. A motion was made to approve the request by Mr. Bender seconded by Mr. Lewis and carried with a 5 to 0 vote.

Dr. Camp presented requests from Coach Spencer to have Brad Miller and Kurt Weatherholt as volunteer assistant wrestling coaches at North Posey High School. A motion was made by Mrs. O'Risky to approve the requests and Mr. Bender seconded the motion. The motion carried with a 5 to 0 vote.
