Mr. Schmitt made a motion to approve the consent items as presented and Mrs. Will seconded the motion. Mr. Kahle opened discussion regarding the claim paid to Concept Sound and Light. The motion passed 5 to 0.

New Business

Public Hearing for the 1028

Mr. Gentil opened the public hearing for the 1028 at 6:45 p.m. Mr. Galvin shared with the School Board that postings for the 1028 hearing had been posted at each school location, Central Office, posted on the District website, and published in the Posey County News. Financial consultants from Bose McKinney & Evans LLP and Stifel Public Finance were present to explain and answer questions about the bonding process. Mr. Oakley voiced his concern with this process and how it may be viewed among our tax payers. Mr. Gentil opened the floor to any questions or comments to any patrons. As there were no patrons present to comment, the public hearing for the 1028 was closed at 7:08 p.m.

Public Hearing for the Additional Appropriation

Mr. Gentil opened the public hearing for the Additional Appropriations at 7:08 p.m. Mr. Galvin shared with the School Board that 1028 posting listed the projects the additional appropriations will be used to complete. Financial consultants from Bose McKinney & Evans LLP and Stifel Public Finance were present to explain and answer questions about the bonding process. Mr. Gentil opened the floor to any questions or comments to any patrons. Lois Gray, Posey County News, asked for clarification on appropriations. After her question was addressed, the public hearing was closed at 7:10 p.m.

Mr. Galvin presented for consideration the 1028 Resolution. Mrs. Will made a motion to approve the 1028 Resolution and Mr. Kahle seconded the motion. The motion was approved with a 4 to 1 vote with Mr. Oakley voting nay.

Mr. Galvin presented for consideration the Bond Resolution. Mr. Schmitt made a motion to approve the Bond Resolution and Mrs. Will seconded the motion. The motion was approved with a 4 to 1 vote with Mr. Oakley voting nay.

Mr. Galvin presented for consideration the Additional Appropriation Resolution. Mr. Schmitt made a motion to approve the Additional Appropriation Resolution and Mr. Kahle seconded the motion. The motion was approved with a 4 to 1 vote with Mr. Oakley voting nay.

Mr. Galvin presented for consideration the proposals for scanning of records located in the basement of Central Office. Bids were requested from three (3) vendors, but only two (2) submitted a bid: Van Ausdall and Farrar: \$121,495.00 and Information and Records Associates: \$26,383.51. Mr. Galvin recommended accepting the bid from Information and Records Associates for \$26,383.51. The cost for this process will be paid from the Operations' Fund over the next two budget years. Mr. Oakley made a motion to approve the contract and Mr. Kahle seconded the motion. The motion was approved with a 5 to 0 vote.

Mr. Galvin presented for consideration the installation of a new Administration Area VVT Control System at the North Posey Junior High School at the cost of \$14,875.00 and the replacement of a faulty fire damper at North Posey Junior High School at the cost of \$1,412.00. ESSER III will be used for the VVT Control System and contingency funds will be used to cover the fire damper. Mr. Schmitt made a motion to approve the request and Mr. Oakley seconded the motion. The motion was approved with a 5 to 0 vote.

Mrs. Walden presented for consideration the proposal with Thrive Afterschool Inc. to provide service and training for their bus transportation. Mrs. Will made a motion to approve the request and Mr. Schmitt seconded the motion. The motion was approved with a 5 to 0 vote.
