Executive Session

The Board convened the Executive Session at 5:30 p.m. for the purpose of IC 5-14- 1.5-6.1 (9) to discuss a job performance evaluation of individual employees. The Board adjourned Executive Session at 6:27 p.m.

Regular Meeting

The Board of Education convened for the regular meeting at 6:41 p.m. with President, Greg Schmitt, calling the meeting to order with the initiation of the Pledge of Allegiance.

Patron Concerns

Mr. Schmitt asked the Board for a motion to approve the consent items as listed:

Mrs. Will made a motion to approve the contract and Mr. Oakley seconded the motion. The motion was approved with a 4 to 0 vote.

Dr. Galvin presented for consideration the 2024 Budget Calendar. Mrs. Will made a motion to approve the request and Mrs. Bowers seconded the motion. The motion was approved with a 4 to 0 vote.

Dr. Galvin presented for consideration the revisions to the 2023-2024 calendar with changes to the professional development days; removed the August and January days. In addition, two options for the 2024-2025 calendar were presented to the Board for approval. Dr. Galvin informed the Board that both options were presented to the teacher association for their input and they in turn polled all teachers. The majority preferred Option 1. Mrs. Will made a motion to approve the revised 2023-2024 school calendar as well as Option 1 of 2024-2025 calendars presented. Mr. Oakley seconded the motion. The motion was approved with a 4 to 0 vote.

Dr. Galvin presented for consideration the Memorandum of Understanding with the Southern Indiana Career & Technical Center. Mrs. Bowers made a motion to approve the request and Mr. Oakley seconded the motion. The motion was approved with a 4 to 0 vote.

Dr. Galvin presented for consideration the bids for the North Elementary Exterior Doors and Frames Replacement Project. Sealed bids were opened in the Board Office on Thursday, April 6, 2023, at 1:00 pm. Two bids were received and are listed below. Dr. Galvin recommended accepting the base bid from Keusch Glass at \$198,750.00. This project shall be paid from a combination of funds; General Obligation Bond, Homeland Security, and Operations' Fund. Mrs. Will made a motion to approve the request and Mr. Oakley seconded the motion. The motion was approved with a 4 to 0 vote.

Mr. Fisher presented to the Board for consideration a quote from IXL Learning to purchase a three-year subscription to an assessment tool for the high school. The subscription includes up to 450 students and will cover Math and ELA. In addition, it will provide professional development and unlimited instructor accounts. The cost of this subscription is \$20,702 and will be taken from ESSER III funds. Mrs. Will made a motion to approve the request and Mr. Oakley seconded the motion. The motion was approved with a 4 to 0 vote.
