A special meeting of the Board of Education of the MSD of North Posey County, Poseyville, Indiana, was held in the Conference Room of the District Office, on September 23, 2025. The following Board members were present:

Special Meeting

The Board of Education convened for the regular meeting at 3:00 p.m. with President, Vince Oakley, calling the meeting to order with the initiation of the Pledge of Allegiance.

New Business

Mr. Slagle introduced Henry Steckler of Hafer Design to present the bids for the Mechanical Systems Upgrade Project. Mr. Steckler shared the bid tabulation sheet from the September 17, 2025, bid opening:

Mr. Steckler recommended awarding the project to Haase Mechanical with a final bid of \$1,760,000.00. Mr. Schmitt moved to approve Haase Mechanical for the mechanicals project, and Mrs. Bowers seconded the motion. The motion passed with a 5 to 0 vote.

A Special Board Meeting will be held on **Tuesday, October 7, 2025, at 3:00 p.m.** in the District Office conference room to conduct the First Preliminary Determination Hearing and discuss the terms of the tentative agreement of the teacher collective bargaining agreement.
